

Most applicable violation discovered (Permit Modification)



#### Wastewater Discharge Permit-Found in Part 3 Section I. Modifications

The Permitee shall give written notice to the City at least sixty (60) days prior to any facility expansion, production increase, or process modifications that result in new or substantially increased discharge or a change in the nature of the discharge. Variations in flow greater than 20% or changes in the timing of the batch discharge from the Permittee as a result of modifications to the industrial processes must be reported in writing.

Industries that are impacted: EPC-Capital, EPC-Century, Image Industries, MI Windows and Doors, QPC, Texas Finishing Company, United Laboratories, Western Extrusions, and WMC Industrial.

#### Wastewater Surcharges

- ✓ Discharges exceeding 250 mg/L BOD or 250 mg/L TSS are subject to extra strength sewer charges. The city calculates extra strength services charges using flow rates and monitoring results.
- ✓ Evaluated in June and December every year
- ✓ New Billing Cycle starts in July and January every year
- ✓ Additional BOD and TSS self-monitoring samples taken by the industry can be submitted to the City of Carrollton for review. If the self-monitoring samples are credible, then the sample results will be utilize for determining the industries wastewater surcharges.



#### Wastewater Surcharges

- ✓ Wastewater surcharge information is listed on your City of Carrollton industrial wastewater discharge permit.
- ✓ Under PART 8(A): SPECIAL CONDITIONS
- ✓ Surcharge Formula = (Q)  $\{(0.001) (8.34) [a(BOD-250) + b(TSS-250)] (c)\}$
- ✓ Cost for treating BOD= \$0.07966/lb Cost for treating TSS=\$0.9831/lb

✓ Surcharge (0.001) (8.34) [0.07966(1413.67-250)+0.09831 (44-250)] (1.3)= 0.785

### Trunkline Sampling

- ✓ The City of Carrollton's trunkline sampling project includes a flow audit studies for all permitted significant industrial users. The flow audit includes other non-permitted industrial users as well.
- ✓ The City's Trunkline and Outfalls to TRA includes 7 entry points located throughout the City of Carrollton
- ✓ Pollutants affiliated with the City of Carrollton's local limits were sampled such as: As, Cr, Cu, Cn, Pb, Zn, Oil and Grease, BOD, TSS, and pH
- ✓ Slightly elevated levels of TSS and BOD were identified
