- 1. Call to Order
 - a. Ms. Scamardo calls the meeting to order at 7:04pm
- 2. Review and Approve Previous Minutes
 - a. Motion to approve minutes by Mr. Thomas Williams, second by Ms. Natasha Singh. Minutes approved unanimously.
- 3. Museum Property Updates
 - a. Mr. Scallions provides updates on the Museum property. The barn fence and window restoration projects were completed. - Structures Report and stated that the Parks and Recreation Department will put in an ATB budget request. The last Historic Structures Report was in 1986, therefore and updated report will assist in restoring the property.
- ii. Ms. Tribble questions the current security system at the Museum. Mr. Scallions states the Museum currently holds a motion senor and there are exterior cameras set up around the Museum and the park property. Ms. Terri Williams asks if vandalism occurs at the property. Mr. Scallions responded with the recent vandalism to the Gravley Gazebo.
