1. Call the Meeting to Order: 6:30 pm by Mr. Raso

2. Approval or Correction of the Minutes from November 14, 2018

3. Historic Resource Survey Committee Update

4. City Art Conservation Standards Discussion

- c. Councilwoman Cochran inquires if the only area HPAC is working to preserve is the Historic Downtown area. Mr. Scallions states that it will encompass all art areas in the city that was made using city funds.

5. City Cultural Data Discussion

a. Mr. Raso explains that this topic is to compile all the cultural events located in the City of Carrollton and their significance to the cultural community. Mr. Scallions states that many members of HPAC have sent him materials related to the different cultural events and he will create a document that will detail the cultural event, day the event is executed in the city, and the significance of the event.

6. Carrollton Women's Club Centennial Discussion

a. Mr. Raso would like to create a subcommittee to assist in the development of the centennial celebration. Mrs. Castaneda stated she will be on the committee. Further subcommittee members will be detailed at the next meeting. The first task of the subcommittee will be to determine what the Women's Club would like and if there are any other organizations working with the Women's Club for their centennial celebration.
