1. Call to order:

- a. Ms. Scamardo calls meeting to order at 7:06pm.

3. A.W Perry Outdoor Restroom Discussion

The presentation included an overview of the style of the facility to be installed, the exterior aesthetics, and additions to the restroom facility, including a storage area and exterior water fountain.
- b. The board discussed their preference on the facility including style of slats, water fountain and sidewalk design, ADA and family changing areas inside restroom facility, operational hours, and security of the outdoor restroom with recommendations.


4. Update on the A.W. Perry Museum
