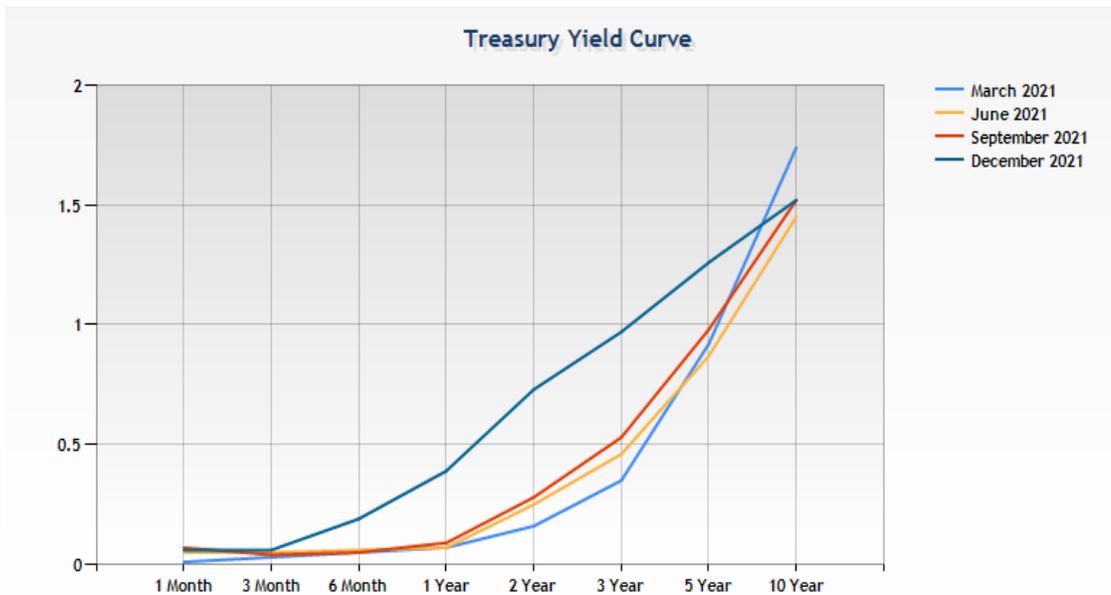
ECONOMIC SUMMARY AND INVESTMENT STRATEGY

First Quarter Ended December 31, 2021

The U.S. Economy This Quarter

Economic activity across the United States expanded at a modest pace in the final weeks of 2021. The economic growth was constrained by ongoing supply chain disruption and labor shortages. Demand for materials, inputs, and for workers, remained elevated among businesses. Lending activity picked up slightly, led by commercial real estate borrowers. The manufacturing sector continued to expand nationally. Activity in the transportation sector expanded at a moderate pace. Employment grew modestly, job openings were up but overall payroll growth was constrained by persistent labor shortages. Prices charged to customers continued to grow influenced by supply shortages.

The yield on the 10-year U.S. Treasury bonds increased to 1.47 percent in December 2021 from 1.37 percent at the end of September 2021. The 2-year T-note yield increased to 0.68 percent in December 2021 from 0.24 percent in September 2021. As a result, the spread between these benchmarks decreased in December 2021 to 79 basis points from the previous quarter's 113 basis points.



DFW Economy This Quarter

The Federal Reserve's Beige Book reported a solid expansion in the Dallas (eleventh) district for the last quarter. Growth in manufacturing, nonfinancial services, and retail sectors stayed strong, and growth in financial services picked up. Home sales remained elevated and apartment leasing continued to grow. Employment rose robustly, and wage growth remained highly elevated due to widespread labor shortages. Supply chain disruptions continued to drive costs up, and prices rose at a rapid speed. The unemployment rate decreased in Dallas and Fort Worth from 4.6 percent to 4.0 percent, and from 4.8 percent to 3.8 percent respectively from September 2021 levels. Both unemployment rates are lower than the state unemployment rate of 5.0 percent but closer of the nationwide unemployment rate of 3.9.

Economic Outlook

The Federal Open Market Committee (FOMC) has maintained the target rate of 0.00 – 0.25 during its January 25-26 meeting. The FOMC seeks to achieve maximum employment and inflation at the rate of 2 percent over the longer run. With inflation well above 2 percent and a strong labor market, the Committee expects it will soon be appropriate to raise the target range for the federal funds rate.

The path of the economy continues to depend on the course of the virus. The Fed decided to continue to reduce the monthly pace of its net asset purchases, bringing them to an end in early March. Beginning in February, the Fed will increase its holdings in Treasury securities by at least \$20 billion per month and of agency mortgage-backed securities by at least \$10 billion per month. The Fed's ongoing purchases and holdings of securities will support the flow of credit to households and businesses. The Fed's next meeting is March 15-16. The Fed fund futures market expects a change on the fed funds rate in March 2022.

ECONOMIC SUMMARY AND INVESTMENT STRATEGY

First Quarter Ended December 31, 2021

City of Carrollton's Portfolio Performance This Quarter

The Consolidated Portfolio had an overall quarterly rate of return of 0.40 percent gross at the end of December 31, 2021. The gross rate of return for this quarter was 1 basis points lower from the previous quarter as a result of a decrease on yields in the market. The rate of return of Carrollton's Consolidated Portfolio for this quarter was 24 basis points higher than the average of the 1-year and 2-year rolling average yield of Treasury Notes as result of funds invested in previous months on securities with a higher yield. The year to date gross rate of return at the end of the quarter was 0.40 percent

The weighted average maturity (WAM) of all the portfolios at quarter end was 1.31 years, a decrease from 1.58 years at the end of last quarter. The City's portfolio currently has a short-term duration (refer to graph #3 of the Executive Summary) with about 45 percent of the portfolio under one year, 27 percent from one year to two years, 26 percent from two years to three years, and 2 percent from three to five years. The City's portfolios are diversified at quarter-end in government coupon agencies at 42 percent, municipal bonds at 27 percent, treasuries at 9 percent, and government pools and bank accounts at 22 percent of the total.

The book value of all combined portfolios at the end of the quarter was \$348,644,945 with a market value of \$347,134,928. The difference represents an unrealized loss of \$1,510,018 (99.57%) of book value for the combined portfolios.

A detailed breakdown of income earned, yields, holdings, market sector diversification, market value, and book value by portfolio and asset type for the City's portfolios are contained in this investment report.

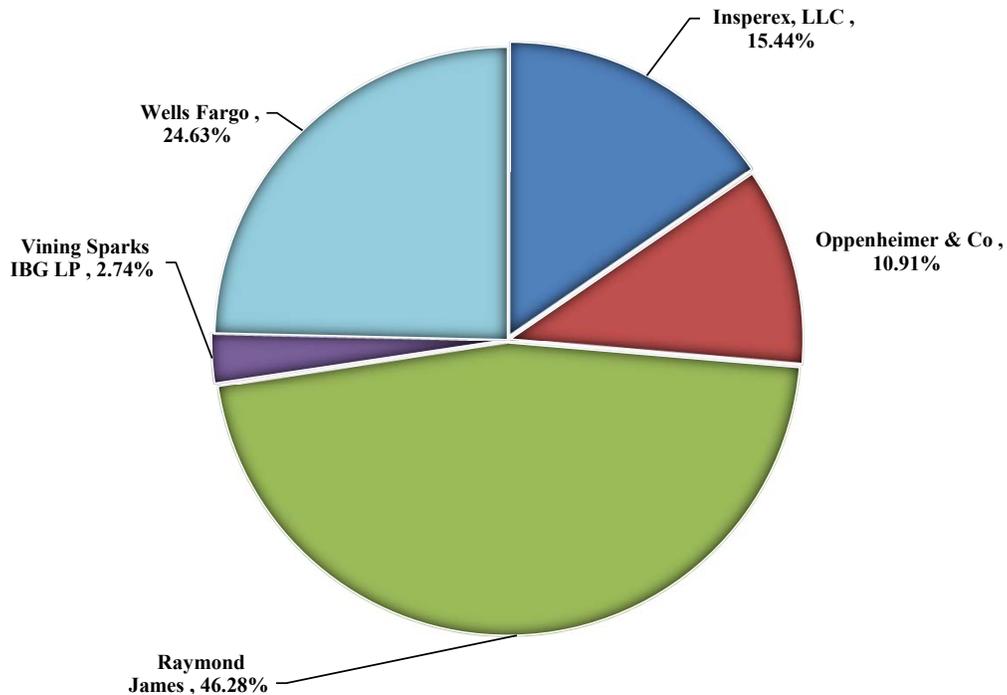
