

INVESTMENT OFFICER'S QUARTERLY REPORT

First Quarter Ended December 31, 2022





To The Honorable Steve Babick, Members of the City Council, and City Manager, City of Carrollton

The Annual Investment Officer's Report addresses only those funds managed by the City of Carrollton, Texas. The investment income earned in capital project funds is used to reduce administrative expenses charged to each project. The investment income earned is recorded in the budget as a revenue source that reduces the need for additional taxes.

The preparation of this report was accomplished with the assistance of several staff members of the City's Finance Department who provided administrative support, financial data, or analysis work on a particular part of the report. A review and approval process was carried out by the City Treasurer and the Chief Financial Officer.

Those listed below who have signatures by their printed names are investment officers of the City and are required by State law to sign this report. As of December 31, 2022 the investment officers acknowledge that the City's investment portfolios have been and are currently in compliance with the policies and strategies contained in the City's Investment Policy and in compliance with the requirements of section 2256.023 of the Public Funds Investment Act of the State of Texas.

The City of Carrollton investment reports, policies and strategies have been approved and adopted by the governing body by Resolution.


Unemployment Rate (1)

The US unemployment rate remained unchanged in December 2022 from September 2022 matching a 50 year low reached in 2020 before the pandemic. Although some companies are starting to lay off, labor markets remained tight and wage pressure remained elevated.

Inflation Rate (2)

The annual inflation rate in the US slowed down for a sixth straight month running to 6.5% in December 2022, the lowest since October 2021. Freight costs and prices for some commodities, such as steel and lumber continued to decrease. Food prices increases slowed down along with autos, computers, and sporting goods.




Federal Fund Rate (1)

Markets expect the U.S Federal Reserve (FED) to raise rates again on February 1, 2023 by 25 basis points to a funds target rate range⁽³⁾ of 4.5-4.75. The FOMC anticipates that ongoing increases in the target range will be appropriate to attain a stance of monetary policy that is sufficiently restrictive to return inflation to 2 percent over time.

Leading Economic Indicator (2)

The Leading Economic Index (LEI) decreased by 0.1 percent in November 2022, after a decline of 0.9 percent in October anticipating a possible economic contraction as labor market, manufacturing and housing indicators decline.




Housing Inventory (1)

The unsold inventory increased to 2.9-month supply from 1.8 in December 2021. Properties remained in the market for 26 days in December 2022 compared to 24 days in December 2021. This increase reflects the rapid increase in mortgage rates and home median prices.

Existing Home Sales (2)

Existing-home sales decline for the eleventh consecutive month to a seasonally adjusted annual rate of 4.0 million. Sales slipped 1.5% from November 2022 and 34% from the previous year. The median existing home price for all housing type was \$366,900 in December 2022 compared to \$358,800 in December 2021.




Treasury Yield Curve (1)

The yield on the 10-year U.S. Treasury bonds increased to 3.62 percent in December 2022 from 3.52 percent at the end of September 2022. The 2-year T-note yield increased to 4.29 percent in December 2022 from 3.86 percent in September 2022. As a result, the spread between these benchmarks increased to 67 basis points in December 2022 from the previous quarter's 34 basis points.

Municipal Bonds Bloomberg Index (2)

The 10-year Muni Bond AAA decreased to 2.62 in December 2022 from 3.26 percent in September 2022. The yield for 2-year Muni Bond AAA decreased to 2.66 percent in December 2022 from 3.07 percent at the end of September 2022. As a result, the spread between these benchmarks decreased to 4 basis points in December 2022 from the previous quarter's 19 basis points.

Portfolio Values and Net Investment Earnings

First Quarter Ended December 31, 2022

The City has unrealized losses of \$9,976,502 as of December 31, 2022 for all combined portfolios due to the current rising rate environment. The City portfolio has been structured in accordance to its Investment Policy requiring the purchase of low risk securities to ensure preservation of principal and liquidity to meet cash requirements for ongoing operations. This strategy allows the City to hold securities until maturity preventing the realization of losses in a raising rate environment.

Portfolio Yields

First Quarter Ended December 31, 2022

The Consolidated Portfolio had an overall quarterly rate of return of 1.63 percent gross at the end of December 31, 2022. The gross rate of return for this quarter was 67 basis points higher from the previous quarter as a result of an increase on yields in the market. The rate of return of Carrollton's Consolidated Portfolio for this quarter was 92 basis points lower than the Benchmark Rolling Average for the current quarter. The underperformance is a result of fast increase of interest rates in the last year. The 1-2 year average yield benchmark has increased 239 basis points since December 2021.



Consolidated Portfolio and Benchmark Yields








Portfolio Diversification by Issuer



The City is compliant with the investment policy, adopted on November 15, 2022 with resolution 4666. The Investment Policy requires a diversified portfolio to reduce credit and market risk by limiting concentration of assets in a specific maturity, a specific issuer or a security type.

Weighted Average Maturity

First Quarter Ended December 31, 2022

The weighted average maturity (WAM) of all the portfolios at the end of the quarter increased to 1.06 years from 0.87 years. The City's portfolio has a short-term duration with maturities about 53 percent under 1-year, 30 percent from 1-2 years, 16 percent from 2-3 years, and 1 percent from 3-4 years.
