A review of the HUD approved PY22 Action Plan at the beginning of January 2023 by the city staff resulted in consultations with the regional HUD representatives regarding activities funded for Homelessness. The funding allocated for this purpose was found to exceed the Public Services Cap allowed. The revisions to the PY22 Action Plan will address this issue and provide allocation for other activities/projects.

Executive Summary

AP-05 Executive Summary

1. Introduction

This document represents the fourth year of the Five-Year Consolidated Plan for the City of Carrollton, Texas and will cover the 2022 Program Year. The City of Carrollton is expected to receive \$769,827 in Community Development Block Grant Funding (CDBG) from the U.S. Department of Housing and Urban Development (HUD) for the 2022 Program Year (PY22). The PY22 Action Plan builds on local assets and coordinates a response to the needs of the community. It integrates economic, physical, environmental, and community responses to the needs for residents of Carrollton who are of low- to moderate- income.

2. Summarize the objectives and outcomes identified in the Plan

The objectives found in the PY22 Action Plan follow the objectives outlined in the 2019-2023 Consolidated Plan submitted to HUD for the use of CDBG funds.

3. Evaluation of past performance

The City of Carrollton's CDBG investments have been used in the past to make long lasting improvements to many low- to moderate- income neighborhoods. These investments have allowed housing stock to remain in good condition and retain affordability for low- to moderate- income renters who want to become homeowners; they have also allowed elderly residents to age in place.

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

The PY22 Action Plan is being amended to address improper funding related to a Public Services activity to address homelessness. The funding exceeded the 15% allocation cap requiring the city to amend the PY22 Action Plan and to introduce other activities to be CDBG funded. The city published legal notice in the Dallas Morning News on Sunday, February 26, 2023, which ran for 15 days announcing the amended PY22 Action Plan. There was also a public hearing on the amended plan at the Carrollton City Council meeting on Tuesday, March 21, 2023.

5. Summary of public comments

The amended PY22 Action Plan was required to be performed due to an inconsistency with HUD CFR requirements relating to the 15% funding cap for Public Service duties. The review was able to identify the issue prior to 15% funding cap for Public Services being exceeded, therefore no CDBG funding spent has to be recalled. Per information provided by our regional HUD representatives the city posted legal notice of the amended PY22 Action Plan in the Dallas Morning news, posted the amended plan on the city web site, and held a public hearing before the Carrollton City Council on Tuesday, March 21, 2023.

1. Introduction

As part of the 2019-2023 Consolidated Plan process the City of Carrollton consulted with residents and stakeholders (e.g., social service providers, local school districts, City departments and other community partners). Consultation included a stakeholder focus group, interviews, and a public meeting during a Neighborhood Advisory Commission meeting to obtain citizen participation in the Consolidated Plan process. The five-year Consolidated Plan serves as the guiding process for the Action Plans developed during the 2019-2023 timeline.

As needed, the Community Services Division provides technical assistance and information to private and public organizations that seek to provide affordable housing and support services to residents of Carrollton. The amended PY22 Action Plan for the City will continue to promote and emphasize the need for greater coordination between all agencies active in Carrollton so as to minimize the duplication of efforts. Cooperative efforts in applying for available funds will be initiated between public and private housing providers so as to maximize the potential for being awarded funds by the State and Federal Government. Efforts to enhance coordination between the public and private sector will ensure that needs are being properly addressed and that resources are being maximized.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

Carrollton is represented by Dallas County and Denton County in the two Continuums of Care that overlap the city's boundaries—the Dallas Area Consortium on Homelessness and the Denton County Consortium on Homelessness. Carrollton staff continues to participate with local social service agencies in the Point in Time Count to identify homelessness in the community. As shown by the count results, chronic homelessness is an emerging issue in the city. While a supportive partner to the Consortia's efforts to strategically address homelessness in the region, Carrollton's most direct efforts to address the needs of homeless residents result from a strong partnership with Metrocrest Services, the area provider of all manner of services to assist vulnerable households.

The City of Carrollton is not currently part of area Continuum of Care networks and is represented by Dallas and Denton counties in the Dallas Area Consortium on Homelessness as well as the Denton County Consortium on Homelessness. Carrollton has a supporting role, offering assistance to agencies that are working to mitigate homelessness in the region.

The initial citizen participation process included notification of social service focus group and a Neighborhood Advisory Commission meeting attended by members of the public, representatives of the social service providers, and leaders of Carrollton neighborhood organizations. Housing and community development needs identified by participants validated needs shown in the market and housing analyses as well as the professional experience of City staff and service providers. This in turn helped shape the goal setting process to address the identified needs. The changes for the amended PY22 Action Plan were posted for comments in the Dallas Morning News, the amended plan posted on the city web site, and one public hearing before the City Council asking for comments relating to the proposed changes.

Introduction

The City of Carrollton was allocated \$769,827 in PY22 Funding from the U.S. Department of Housing and Urban Development (HUD). This funding will be used along with CDBG appropriates allocated in Prior Year funding to the city for the city's Minor Home Repair Program, Emergency Repair Program, People Helping People Program, funding for a Code Enforcement Officer to work in the low - to moderate- income target area, and start up funding for two programs for Metrocrest Services addressing a need to prevent homelessness in Carrollton, and to address those that are already homeless within the city, infrastructure projects in Carrollton Heights Neighborhood and Crosby Estates Neighborhood, Nolan Drive alleyway repair/replacement and Crockett Drive alleyway replacement in the LMI area, and in Administration for training of staff. This is an amendment to the original PY22 Action Plan submitted due to incorrect allocation given to Metrocrest Services for homeless action due to being classified as a Public Service with a 15% cap.

The Community Services Division for the City of Carrollton is the lead agency for the implementation of the community development plan related to CDBG funding. Internally the Community Services Division works in collaboration with all city departments to deliver projects, services, and other benefits to eligible neighborhoods and clients. Externally, the Division works with a number of social service agencies/organizations so long as the need is documented and eligible under HUD regulations.

To effectively implement the Community Development Plan, funding comes from CDBG funds as well as General Funds allocated by the City Council. The City Council will make available an estimated \$450,000 in General Fund resources to fund agencies and organizations that are actively engaged in the provision of social services in Carrollton.

In exchange for the funding, the agencies and organizations work closely with the City in the provision of social services to all Carrollton citizens in need. The close partnership the City has with each agency grows with each year of collaboration. A total of four (4) staff in the Community Services Division are employed for the administration of CDBG grant funds and planning activity, to provide technical knowledge, referral and capacity building assistance for the agencies on an ongoing basis.

The list below identifies some of the principle social service providers for the City's priority funding and service development:

- Bea's Kids
- CASA of Denton County
- Children's Advocacy Center for Denton County
- Metrocrest Services
- WOVEN Medical Clinic

The City meets with all of its partners on an as-needed basis to develop organization capacity and programming offering. Staff also regularly provides technical assistance and professional expertise to further develop institutional structure for all agencies and organizations serving the low - to moderate-income citizens of Carrollton.

	Goal Description	Due to an improper interpretation of HUD rules/regulations the PY22 Action Plan is being amended to make the necessary changes to comply with funding requirements. The initial allocation to address homeless issues to Metrocrest Services required being adjusted and the city identified other areas for funding which met the criteria established in the city's Consolidated Plan. The initial CDBG allocation was \$600,000 however reclassification as a Public Service imposes a 15% cap on the allowable CDBG funding. This allocation is required to be reduced to \$115,000 to meet CDBG requirements. The city identified other areas for allocating CDBG funding for infrastructure projects which will be in line with Section 3 requirements. The social service agencies will be receiving allocations from the General Fund by the City Council to target low- to moderate- income residents for assistance. These programs assist with addressing homelessness, medical attention, children's programs, food banks and such. The goal is to assist 15,000 individuals in all aspects of social service needs using both CDBG funds and city General Funds. CDBG funding allocated to Metrocrest Services is \$650,000 to address homeless issues, with the other social service programs and agencies receiving city General Funds in the amount of \$450,000.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The priorities for the PY22 Action Plan are being adjusted based on identification of the greatest needs in Carrollton, as described in the MA and NA sections of the 2019-2023 Consolidated Plan. Because of a misallocation of funding exceeding the Public Services allowance the city has moved to an allocation of \$1,205,000 in CDBG funding for the PY22 Action Plan. The specific allocations of those funds are as follows:

- \$200,000 in CDBG funding for infrastructure project for Carrollton Heights neighborhood.
- \$200,000 in CDBG funding for infrastructure project for Crosby Estates Section 1 neighborhood.
- \$200,000 in CDBG funding for Public Works infrastructure repair/replacement of alleyway for the odd number side of Nolan Drive.
- \$200,000 in CDBG funding for Public Works infrastructure repair/replacement of alleyway for the odd number side of Crockett Drive.
- \$180,000 dedicated to the City's Housing Rehabilitation Programs (Minor Home Repair, Emergency Repair, and People Helping People)
- \$115,000 in CDBG funding for Metrocrest Services to create programs to address issues of

homelessness in Carrollton.

- \$95,000 in funding for Enhanced Code Enforcement in the CDBG Target Area
- \$15,000 in Administrative Training of Community Development staff to identify and remain informed on use of CDBG funding provided to the city.

For the PY22 Action Plan, CDBG funding for the NOTICE program will be allocated to CDBG - eligible priority neighborhoods. Neighborhoods receiving improvements are ranked according to infrastructure needs.

For the 2019-2023 Consolidated Plan, low and moderate income (LMI) areas were identified using the HUD provided Low- and Moderate- Income Summary Data (LMISD) for PY2020 as detailed in CPD Notice 19-02. The underlying data in the LMSID are from the 2011-2015 ACS.

The calculation used to identify LMI areas was:

- 1. Determine average household size by Census Tract using 2012 ACS;
- 2. Determine the LMI ceiling by tract, which is 80% of the median family income limit closest to the tract-level average family size;
- 3. Using household income distribution data from the ACS, determine the number of households in the tract that earn less than the LMI ceiling;
- 4. Calculate the proportion of the tract's households that the LMI households represents.

During the PY22 Action Plan year, the City of Carrollton will allocate funding geographically toward Enhanced Code Enforcement of apartment communities within the NOTICE Priority Target Area of the city. Infrastructure projects were identified for Carrollton Heights and Crosby Estate neighborhoods. Public Work projects were identified for alleyway repair/replacement in the 2200 Block of Nolan Drive and the 2200 Block of Crockett Drive. All of these projects fall within the NOTICE Priority Target Area.

Rationale for the priorities for allocating investments geographically

Apartment communities located within the Low- to Moderate-Income (LMI) area are comprised of approximately 6,300 units. These multi-family communities tend to be older communities built during a period in which construction codes were weaker than they are currently. Also, ownership of those communities at times fail to take prompt action to maintain their properties on a regular basis, forcing the city to act to gain compliance so the residents may reside and live in a manner which is safe to their

families.

Discussion

Revision of the PY22 Action Plan occurred due to a misallocation of CDBG funding for Public Service work. By correcting this issue the city will be performing infrastructure projects in multiple areas of the LMI target area. This will result in 74% of CDBG funding being directly identified by geographic distribution in neighborhoods occupied by those of low- to moderate- income.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Outreach to persons experiencing homelessness is done through the City's partners, primarily Metrocrest Services. If City staff, such as members of law enforcement, encounter persons experiencing homelessness, referrals to Metrocrest Services are made. In previous Action Plans Carrollton allocated a portion of General Funds each year to supporting Metrocrest Services and other social service providers and their efforts to prevent homelessness and provide needed services to the homeless population. The needs of persons who are homeless are assessed routinely as part of program provisions. In 2022 Carrollton continued to participate in the Point In Time Count, recognizing that chronic homelessness is an emerging issue in Carrollton. Families meeting the McKinney-Veno definition of homelessness are identified by the school district and also receive referrals to Metrocrest Services or other appropriate providers. Carrollton's philosophy is to put resources into the hands of local experts who are best positioned to assess and serve those experiencing homelessness.

Addressing the emergency shelter and transitional housing needs of homeless persons

Area homeless service providers would like a more sophisticated and coordinated effort to address the needs of the homeless and at-risk population in Carrollton; this includes some type of transitional shelter or housing. Funding constraints have been the primary barrier to creation of a more comprehensive approach to homelessness in Carrollton.

The chronically homeless require wrap around services that are not always cost effective to provide in a small community like Carrollton; as such, Carrollton service providers and the City staff sometimes must refer individuals with more intensive supportive service needs, such as permanently supportive housing, back to urban centers to access needed services.

The City of Carrollton will continue to support strengthening the capacity of local service providers to assist persons who are homeless or at-risk of homelessness through general fund contributions. The City plans to make an estimated <u>\$450,000</u> available for social service programming in General Fund resources. Much will be used to assist persons living in poverty who are at risk of homelessness as well as persons experiencing

homelessness. The City will also be allocating \$115,000 in CDBG funding to Metrocrest Services in order to fund two (2) programs addressing homeless in Carrollton.

This includes funding organizations to provide counseling services, childcare, transitional housing, health care, drug and alcohol detoxification, classes on parenting skills, access to medical facilities and communitybased family support centers, job training, and rental and utility payment assistance.

Services funded by Carrollton and delivered by Metrocrest Services to families who are experiencing housing instability, including the homeless population and those on the verge of homelessness, include:

- Case Management: Comprehensive evaluation and assessment of individual needs
- Housing instability prevention strategies
- Rent/Mortgage assistance
- Utility assistance
- Financial literacy education including budgeting and financial management
- Wraparound services such as GED prep, employment services, education and certification at local colleges
- Medical/Dental/Vision assistance
- Emergency food assistance
- Emergency clothing assistance
- Emergency housing assistance
- Transportation assistance (DART passes, gas cards)
- Minor home repair assistance (seniors only)
- Seasonal programs: holiday food and gifts, summer food, back to school supplies
- Tax preparation assistance
- Information and referral support •

AP-75 Barriers to affordable housing

Introduction:

Carrollton updated its Analysis of Impediments (AI) to Fair Housing in the fall of 2020. The AI identified the following impediments:

1. The city's zoning and land use code could be improved to better align with best practices and minimize the potential for disparate treatment which affects people with disabilities.

2. Lack of affordable rental housing in Carrollton disproportionately impacts Hispanic residents and large families.

3. Residential credit difficult to access for minority households in Carrollton.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The updated AI made the following recommendations to address the identified impediments.

1. City incorporate an accommodation policy into the zoning and land use code to increase awareness and understanding of this policy.

2. Increase the inventory of affordable rentals in Carrollton by continuing to support the development of subsidized rentals which are affordable to residents earning less than \$25,000 up to \$50,000 per year.

3. Improve personal credit and financial literacy by working with nonprofit housing partners to offer Public Service Announcements and other forms of outreach regarding good lending decisions and how to be aware of predatory lending practices.

4. City should continue funding of home improvement and modification repair programs to assist low - income residents with home improvements, accessibility modifications, and repairs that they cannot afford or for which they cannot access residential credit from the private sector.

Actions planned to address obstacles to meeting underserved needs

Limited funding and resources to address the most complicated situations (e.g., chronically homeless) are the primary obstacles to meeting underserved needs in Carrollton. The City will allocate approximately \$450,000 in General Funds to its social service partners to help meet the basic unmet needs of residents including food, medical care, clothing and emergency housing assistance.

Actions planned to foster and maintain affordable housing

Housing actions will be accomplished through existing efforts to preserve affordable housing through neighborhood and housing unit improvement through the Minor Home Repair Program.

The City will also provide information to all program applicants regarding the hazards of lead-based paint, display and distribute materials on lead-based paint hazards during annual community events.

Actions planned to reduce lead-based paint hazards

Mitigating lead-based paint hazards will mostly be accomplished through lead-paint testing and, if lead is found, abatement through the Minor Home Repair Program.

The City will also provide information regarding the hazards of lead-based paint and display and distribute materials on lead-based paint hazards during annual community events.

Actions planned to reduce the number of poverty-level families

The City's anti-poverty efforts that will be undertaken during the 2019-2023 Consolidated Plan period are detailed in SP-70. During the Action Plan year, the following activities will be continued:

- Continue to plan for how to better coordinate local resources to increase educational opportunities for low-income persons in order to improve their ability to earn better wages.
- Examine the linkage between job training programs and local job creation efforts. Ensure job training matches expected and growing employment opportunities.
- Promote financial counseling and classes on budgeting and money management.
- Examine and identify opportunities for improvements in linkages between housing, employment

Citizen Participation Comments for PY22 Action Plan

June 9, 2022 – First Public Hearing before the Neighborhood Advisory Commission

The first scheduled public hearing was scheduled to be held on June 9, 2022 before the Neighborhood Advisory Commission. Unfortunately there were not enough commissioners in attendance to form a quorum for the meeting. The official meeting was cancelled but staff still presented the PY22 Action Plan to those in attendance in order to elicit any feedback on the PY22 Action Plan. Comments from those in attendance addressed the shift in funding away from infrastructure projects to social services addressing homelessness. Staff informed them of the changes in Section 3 requirements made it exceedingly burdensome for contractors to meet the new requirements. Also, the city has seen a large increase in homeless in Carrollton based on the point and time count and the homeless camps found by city staff.

July 22, 2022 – Second Public Hearing before the Carrollton City Council

The second scheduled public hearing was held before the Carrollton City Council on July 12, 2022. This public hearing became the main focus of eliciting responses from the public. At the time of the city staff answered questions from the mayor and city council members relating to the proposed changes in shifting CDBG funds from infrastructure to homelessness. Staff outlined the changes in Section 3 requirements and answered questions from the council directly related to Section 3 changes. Councilmember Sung inquired about financial requirements for residents to meet in order to qualify for CDBG projects. Councilmember Polter made a statement he was happy to see funds being shifted to an area which addresses a serious issue that has been increasing in the city of late. One individual from the public, Al Overholt, addressed the council during the public hearing. He stated he supported the change and shifting of funds to address the homeless issue and that he hoped the city council would not decrease funding from non-CDBG funds to social service agencies during the upcoming budget process.

City staff did not receive any public comments based on information given to social service agencies. Staff didn't receive any public comments from the posting of the PY22 Action Plan on the city web site, or from the posting in the Dallas Morning News.

March 21, 2023 – Public Hearing before Carrollton City Council for amended Program Year 2022 Action Plan

An amended PY22 Action Plan was required to be submitted due to an error on funding allocation for Public Services activities by Metrocrest Services. Staff was able to identify other projects which could meet funding restrictions. A legal notice was placed in the Dallas Morning news on Sunday, February 26, 2023 to allow the public to comment on the amended PY22 Action Plan and to inform
