The Annual Investment Officer's Report addresses only those funds managed by the City of Carrollton, Texas. The investment income earned in capital project funds is used to reduce administrative expenses charged to each project. The investment income earned is recorded in the budget as a revenue source that reduces the need for additional taxes.

The preparation of this report was accomplished with the assistance of several staff members of the City's Finance Department who provided administrative support, financial data, or analysis work on a particular part of the report. A review and approval process was carried out by the City Treasurer and the Chief Financial Officer.

Those listed below who have signatures by their printed names are investment officers of the City and are required by State law to sign this report. As of March 31, 2023 the investment officers acknowledge that the City's investment portfolios have been and are currently in compliance with the policies and strategies contained in the City's Investment Policy and in compliance with the requirements of section 2256.023 of the Public Funds Investment Act of the State of Texas.

The City of Carrollton investment reports, policies and strategies have been approved and adopted by the governing body by Resolution.




Unemployment Rate (1)

The US unemployment rate remained flat from last quarter. Job gains have picked up in recent month. Labor markets started to shift slightly in favor of employers, with certain sectors showing signs of decelerations. In Texas, the unemployment rate increased showing a contraction in the manufacturing sector that was offset by a moderate increase in the service sector.



Inflation Rate (2)

The annual inflation in US decreased from last quarter. Energy cost declined slowly, and food prices grew at a slower rate, prices for used cars and trucks declined. At the same time, costs for housing increased due to high interest rates. Current inflation rate is still above the Federal Reserve inflation target of 2 percent over the longer run, and disinflation is slower than expected.

■ US Unemployment Rate




Federal Fund Rate (1)

As of April 24, 2023 the Fed funds future market reported a 91.4% increase probability of the federal funds target rate to 5.00-5.25 for the Fed meeting on May 3, 2023. Markets expect an increase in rate during the May meeting to slowdown inflation while long- term rate outlook remain uncertain due to the current banking stress status.



Leading Economic Indicator (2)

The US Lending Economic Index (LEI) reached its lowest level since November of 2020. The LEI decreased by 1.2 percent in March 2023, after a decline of 0.5 percent in February 2023, forecasting an economic recession starting in mid-2023.




Housing Inventory (1)

Housing inventory decreased in March 2023 to 2.6-month supply from last quarter's 2.9-month supply. Properties remained in the market for 29 days in March 2023 compared to 17 days in March 2022 as a result of high mortgage rates.



Existing Home Sales (2)

Existing-home sales in March 2023 decreased to a seasonally adjusted annual rate of 4.44 million from 4.58 million in February 2023, a decline of 2.4% from February 2023, and 22% from the previous year. The median existing home price was \$375,700 in March 2023 compared to \$379,300 in March 2022.






Treasury Yield Curve (1)

The yield on the 10-year U.S. Treasury bonds increased to 3.66 percent in March 2023 from 3.62 percent at the end of December 2022. The 2-year T-note yield increased to 4.30 percent in March 2023 from 4.29 percent in December 2022. As a result, the spread between these benchmarks decreased to 64 basis points in March 2023 from the previous quarter's 67 basis points.



Municipal Bonds Bloomberg Index (2)

The 10-year Muni Bond AAA decreased to 2.26 percent in March 2023 from 2.62 percent in December 2022. The yield for 2-year Muni Bond AAA decreased to 2.39 percent in March 2023 from 2.66 percent at the end of December 2022. As a result, the spread between these benchmarks increased to 13 basis points in March 2023 from the previous quarter 3 basis points.

Portfolio Values and Net Investment Earnings

The City has unrealized losses of \$6,929,746 as of March 31, 2023 for all combined portfolios due to the current rising rate environment. The City portfolio has been structured in accordance with its Investment Policy requiring the purchase of low-risk securities to ensure preservation of principal and liquidity to meet cash requirements for ongoing operations. This strategy allows the City to hold securities until maturity preventing the realization of losses in a raising rate environment.

Portfolio Yields

Second Quarter Ended March 31, 2023

The Consolidated Portfolio had an overall quarterly rate of return of 2.76 percent gross at the end of March 31, 2023. The gross rate of return for this quarter was 113 basis points higher from the previous quarter as a result of an increase on yields in the market. The rate of return of Carrollton's Consolidated Portfolio for this quarter was 71 basis points lower than the Benchmark Rolling Average for the current quarter. The underperformance is a result of a quick increase in interest rates. The 1-2 year average yield benchmark has increased 313 basis points since March 2022.







Second Quarter Ended March 31, 2023


The City is compliant with the investment policy, adopted on November 15, 2022 with resolution 4666. The Investment Policy requires a diversified portfolio to reduce credit and market risk by limiting concentration of assets in a specific maturity, a specific issuer or a security type.



Weighted Average Maturity

Second Quarter Ended March 31, 2023

The weighted average maturity (WAM) of all the portfolios at the end of the quarter decreased to 0.90 years from 1.06 years. The City's portfolio has a short-term duration with maturities about 57 percent under 1-year, 26 percent from 1-2 years, and 17 percent from 2-3 years.
