To The Honorable Steve Babick, Members of the City Council, and City Manager, City of Carrollton

The Annual Investment Officer's Report addresses only those funds managed by the City of Carrollton, Texas. The investment income earned in capital project funds is used to reduce administrative expenses charged to each project. The investment income earned is recorded in the budget as a revenue source that reduces the need for additional taxes.

The preparation of this report was accomplished with the assistance of several staff members of the City's Finance Department who provided administrative support, financial data, or analysis work on a particular part of the report. A review and approval process was carried out by the City Treasurer and the Chief Financial Officer.

Those listed below who have signatures by their printed names are investment officers of the City and are required by State law to sign this report. As of September 30, 2024, the investment officers acknowledge that the City's investment portfolios have been and are currently in compliance with the policies and strategies contained in the City's Investment Policy and in compliance with the requirements of section 2256.023 of the Public Funds Investment Act of the State of Texas.

The City of Carrollton investment reports, policies and strategies have been approved and adopted by the governing body by Resolution.

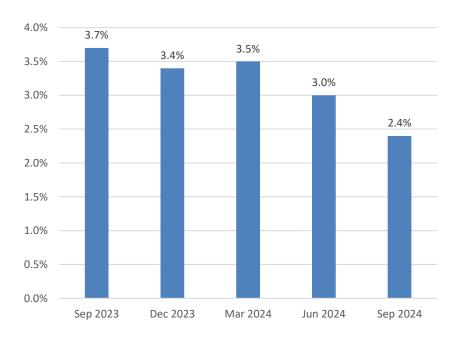
#### Unemployment Rate (1)

In September 2024, the U.S. unemployment rate was at 4.1% (6.8 million unemployed persons). Employment trended up in government, health care, social assistance, and construction sectors. Employment in transportation and warehousing, financial activities, and professional and business services remained relatively unchanged.

#### Inflation Rate (2)

During the fourth quarter, the U.S inflation rate decreased from 3.0% to 2.4% in September 2024. The most significant price decreases occurred for gasoline and energy sectors. Food prices rose slightly during the quarter.

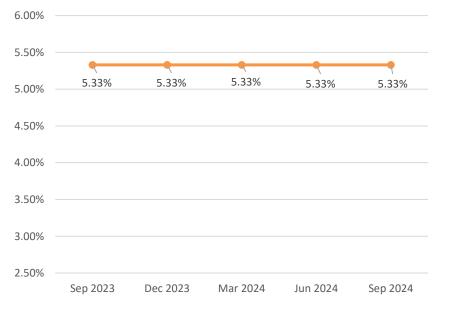

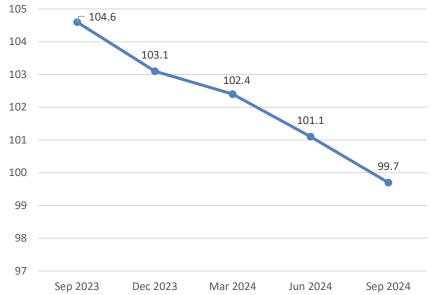
#### Federal Fund Rate (1)

The Federal Open Market Committee (FOMC) cut the federal funds rate in September by 50 basis points from 4.75% to 5.00%. The Committee has gained greater confidence that inflation is moving sustainably toward the 2% target. Economic indicators showed continued solid growth. Inflation remains slightly elevated and the FOMC remains vigilant regarding inflation risks.

In September 2024, the Leading Economic Indicators (LEI) declined to 99.7%. The decline was due to weakness in factory new orders, an inverted yield curve, declining building permits, and a weak consumer outlook. Despite the overall decline during the quarter, some components of the LEI were positive, indicating a cautious outlook for moderate growth into early 2025.

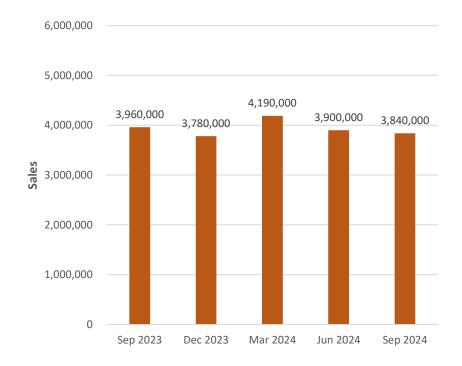

Existing-home sales declined in September 2024 to a seasonally adjusted annual rate of 3.84 million. The median existing-home price for all housing types in September was \$404,500 compared to \$392,700 in September 2023.

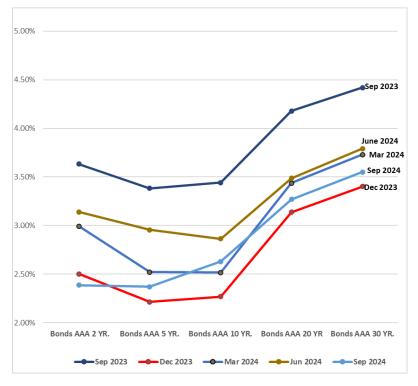
#### Treasury Yield Curve (1)

The yield on the 10-year U.S. Treasury bonds decreased to 3.72% in September 2024 from 4.31% at the end of June 2024. The 2-year T-note yield decreased to 3.62% in September 2024 from 4.74% in June 2024. As a result, the spread between these benchmarks changed 10 basis points in September 2024 from the previous quarter's 43 basis points.

#### Municipal Bonds Bloomberg Index (2)

The yield on the 10-year Muni Bond AAA decreased to 2.63% in September 2024 from 2.86% in June 2024. The yield for 2-year Muni Bond AAA decreased to 2.39% in September 2024 from 3.14% at the end of June 2024. As a result, the spread between the 10-year and 2-year Muni Bond AAA in September 2024 was 24 basis points.

# **Five-Year Comparison Cash and Investment Balances**

#### Fourth Quarter and Fiscal Year Ended September 30, 2024

#### Summary of Cash and Investments, Investment Yields and Earnings

As of September 30, 2024, the City of Carrollton had cash and investments with an amortized book balance of \$422,860,235. Total cash and investments increased \$24,286,192 from September 30, 2023. The increase in the portfolio from the prior fiscal year is related to higher property tax collections, revenue bond proceeds, and investment earnings during the fiscal year.

The City of Carrollton manages the investment portfolio in accordance with the City's investment policy and strategies. The City monitors the portfolio to achieve the maximum income potential, while maintaining the safety and liquidity of the portfolio. The portfolios are relatively short-term in nature, and in a stable rate environment will achieve yields above treasury bill/notes rates of interest.

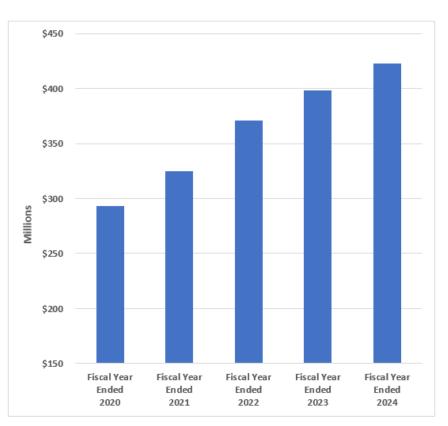

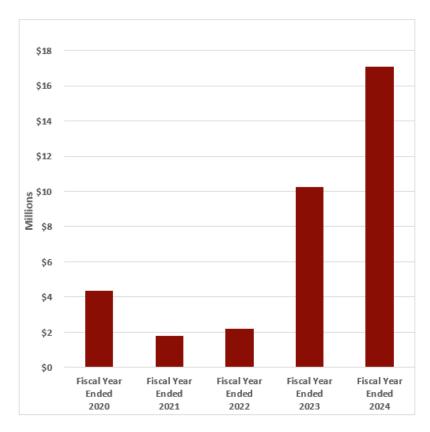

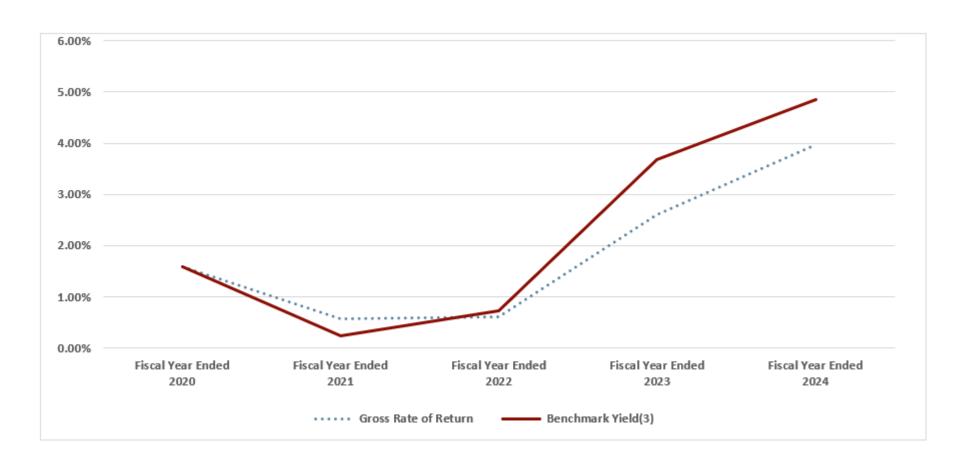

# **Portfolio Values and Net Investment Earnings**

#### Fourth Quarter Ended September 30, 2024

The City portfolio has been structured in accordance with its Investment Policy requiring the purchase of low-risk securities to ensure preservation of principal and liquidity to meet cash requirements for ongoing operations. The book value of the consolidated portfolio at the end of the quarter was \$422,860,235 with a market value of \$424,181,311. The difference represents an unrealized gain of \$1,321,076 (100.31%) of book value for the portfolio.

# **Portfolio Yields**

#### Fourth Quarter Ended September 30, 2024

At the end of September 30, 2024, the Consolidated Portfolio had a gross rate of return of 4.24%, up 4 basis points from the previous quarter. This rate was 60 basis points lower than the Benchmark Rolling Average. However, the gap is closing as lower-yielding securities mature, funds are re-invested at or near benchmark yields, and the Benchmark Rolling Average declined by 11 basis points from the previous quarter.

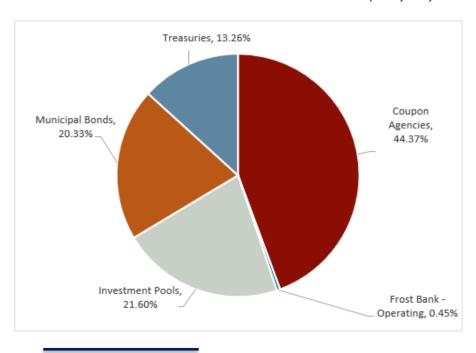

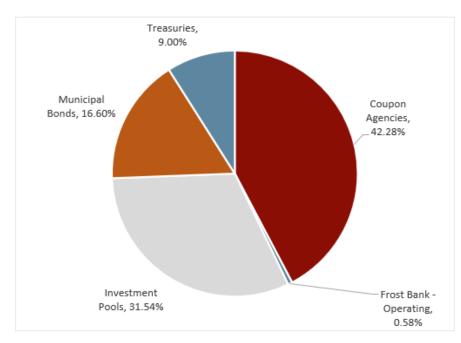

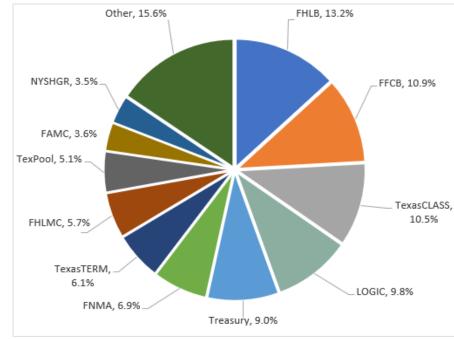
# **Portfolio Diversification by Issuer**

The City is compliant with the investment policy, adopted on November 7, 2023, with resolution 4773. The Investment Policy requires a diversified portfolio to reduce credit and market risk by limiting concentration of assets in a specific maturity, a specific issuer or a security type.

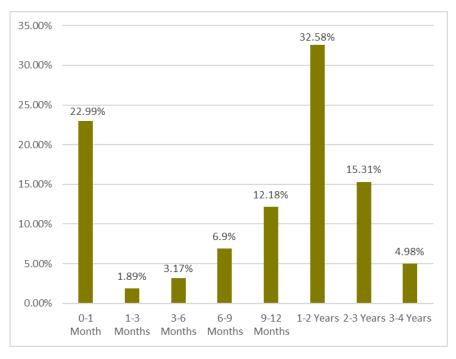


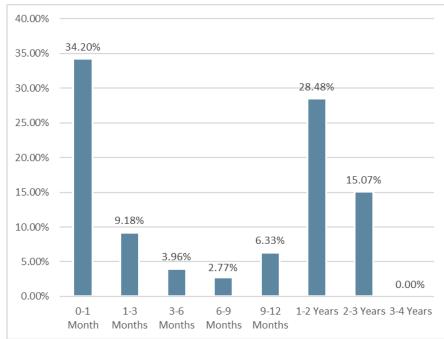
# **Weighted Average Maturity**

#### Fourth Quarter Ended September 30, 2024

The weighted average maturity (WAM) of the portfolio at the end of the quarter increased to 1.26 from 0.88 years. The City's portfolio has a short-term duration with about 47 percent of maturities under 1-year, 33 percent from 1-2 years, 15 percent from 2-3 years and 5 percent from 3-4 years.
